## Please kindly find below Akfen Holding's announcement regarding the date of the Capital Reduction:

At our Company's Extraordinary General Shareholders Meeting, which took place on January 20, 2016, the revision in the Article 6 of the Articles of Association was approved. The extraordinary general meeting was registered at the Ankara Trade Registry on January 20, 2016.

The related share cancellation within this capital reduction will only be applied to the shares acquired within our Company's "share buyback program" making up a total of 5.66% of the Company's paid-in capital with a nominal value of TL14,819,314. There will be no share cancellation related to our Company's other shareholders' Akfen Holding A.Ş. shares.

The required applications, for the cancellation of the shares with a nominal value of TL14,819,314, and for the adjustment in the share price, have been submitted to the Merkezi Kayıt Kuruluşu A.Ş. (Central Registry Agency) and Borsa Istanbul A.Ş. The share cancellation procedure, within the reduction of our Company's paid in capital from the current TL261.9mn to TL247,080,686 will be carried out on 28.01.2016.
