



## Akfen Holding A.Ş.

Please kindly find below Akfen Holding's announcement regarding its share purchases within the "Share Buyback Program":

On 24 January 2014, our Company repurchased a total of 56,462 Akfen Holding shares. Following this transaction the total of share purchases within the frame of the 'Share Buyback Program' so far have reached 14,775,112 shares. The transaction details are shown in the table below. Meanwhile, during the period 27 November 2012 – 11 November 2013, Akfen Insaat has purchased a total of 6,992,099 Akfen Holding shares, and thus in total share purchases have reached 21,767,211 shares. Meanwhile, share purchases have reached 7.48% of the Company's paid-in capital.

Including Akfen Insaat's previous stake, which it held prior to Akfen Holding's public offering on May 14<sup>th</sup>, 2010, share purchases have reached 10.23%.
